What are Cookies and similar technologies?

Cookies are small, often encrypted files of letters and numbers that are stored in browser directories or the hard drive of your computer or electronic device when you visit the website or use applications. The cookies are used to make websites and applications work more efficiently and perform certain functions, e.g., store information about your preferences, provide statistical information to us. This helps us to give you better experience when you browse, and also helps us to make our services better for you.

In this Cookies Policy, we've explained how and why we use cookies, and what each of them do.

FINCI uses following types of cookies:

- First-party cookies (FPC)- cookies stored directly by our website. It allows us to perform useful functions that help provide a good user experience.
- Third-party cookies (TPC)- cookies provided by the third parties, such as Cloudflare, Google, LinkedIn to track website activity such as session duration, pages per session, bounce rate etc. of individuals using the webpage, along with the information on the source of the traffic.

- Functional cookies- cookies are strictly necessary to provide you with services available and to use some of its features. Because these cookies are strictly necessary to deliver our services safely, you cannot refuse them without impacting how our website functions. You can block or delete them by changing your browser settings.
- Analytical cookies- cookies used to count visits and traffic sources, so we can measure and improve the performance of our website. They help us know which pages are the most and least popular and see how visitors move around the site. If you decline these cookies, your visit will not be part of our statistics.
- Marketing cookies- used for user information collection in order to build a profile of visitor interests and then show personalized ads for that specific user. It helps us to be aware of your content preferences on the website to provide you with the most relevant information about our products and services, improve our targeting and enhance your activities on our website. If you decline these cookies, you will experience more generic and less personalized advertising.
